## Consignment Contract

### How our Consignment System Works

We will keep your items displayed in the store up to 120 days.

Prices will automatically be discounted 15% after 60 days and a further 10% after 90 days.

We will keep 50% of the sales price not including HST .

You will not be charged for displaying your items in the store should we be unable to sell your item.

Consignor settlements and payments are ready for pick up on the 15th of the month following the sale of your items. Payment is made to consignors by company cheque and must be picked up at the store.

You are responsible for delivering the items to the store and picking them up if they do not sell. Unsold items must be picked up within one week of expiration.

We do not accept damaged or broken / chipped items.

Upholstered furniture must be very clean and free of any stains.

We do not accept items that have been exposed to heavy smoke or pet hair.

With respect to furniture, we require a photograph be submitted prior to delivery of the item. We will respond in a timely fashion advising you whether the items are saleable in the store. Email the photos to [info@takeitorleaveit.co](mailto:info@takeitorleaveit.co) or feel free to bring the photo to the store. Once we have approved your item for sale we will schedule an appointment to bring the items to the store.

With respect to décor and small items, a drop of appointment should be arranged. We cannot accept more than 10 items at a time. We will view your items when you bring them in and determine which items we can accept. Our only criteria is whether we believe the items are saleable to our customers. Ultimately our customers determine what items are accepted for resale.

It is always our goal to obtain the best possible price for your items. We try to adhere to the set pricing and discount schedule but on occasion we may find it necessary to negotiate the final price with the purchaser. We will not negotiate a price lower than the ticketed price. It is always a good idea to advise us the lowest price you would accept for an item and we will adhere to your wishes.

Once an item has expired it is your responsibility to retrieve the item from the store. Should you choose to not retrieve your unsold items within 7 days of expiration the items will become the property of Take It or Leave It Inc. and will be disposed of or transferred to the store account for further price reductions or donated to a charity of our choice. It remains your responsibility to know your expiration date and retrieve your items within the 7 day period.
